## Affidavit of Agricultural Use

I attest that the building that I am proposing to construct/modify is to be used on land used for the growing of farm crops, truck garden crops, animal and poultry husbandry, apiculture, dairying, floriculture, horticulture, nursery, tree farm, sod farm, pasturage, viticulture, and/or wholesale greenhouse when such agricultural purposes constitute the principal activity on the land together with the operation of any machinery, or vehicles incidental to the above uses.

I attest that the subject property and all incidental uses, structures and equipment thereto, shall relate exclusively to agriculture, and shall not be used for any other purposes. I further attest that all items, including all equipment, vehicles, machinery, and materials stored within any such structures shall be used exclusively in conjunction with the agricultural operation on the subject property and for no other purpose.

I attest that all above statements and statements contained in any papers or plans submitted herewith are true to the best of my knowledge and belief.

I hereby understand that the agricultural zoning exemption does not exempt agricultural uses, buildings and structures from complying with the Water Resource Ordinance or from obtaining building permits and complying with applicable building ordinances.

I hereby understand that any residence in connection with an agricultural use and the residence's water supply and sewage disposal facilities are not exempt and are subject to the regulations of the Will County Zoning Ordinance.

I hereby consent to the entry in or upon the premises described in this application by any authorized official of the County of Will for the purposes of completing any reviews deemed necessary by the submittal of this application.

I hereby understand that the Will County Land Use Department retains the authority to order such structures (or the contents therein) be removed upon evidence that the principal use on the subject property does not relate to agriculture, or that such structures do not relate exclusively to agriculture after I have received an agricultural exemption for the subject property.

I hereby understand that in the event that the land ceases to be used solely for agricultural purposes, the provisions of the Will County Zoning Ordinance will apply.
